## **Experience of Competitive Dialogue**

- Competitive Dialogue as a practical solution to award of complex contracts
- Has been shown to bring benefits when implemented effectively
- Not always implemented effectively (long timetables, high bid costs, difficulty for awarding bodies to achieve objectives)
- Sufficient experience now to highlight effective implementation

## Benefits of Competitive Dialogue – 1


- "Both (the public and private sectors) are in agreement that the process is capable of maintaining sufficient competition"
- "Competitive Dialogue has successfully addressed the issue of protracted post-preferred bidder discussions"
- "Competitive Dialogue has improved procurement outcomes by enabling the public and private sectors to develop and deliver more appropriate, bespoke, value for money outcomes"

# Benefits of Competitive Dialogue – 2



- "Enhanced competitive tension during dialogue (leading to) better value for money/agreement on all vital commercial issues while there is still competition"
- "Better price discipline with less room for "price creep" at the post-preferred bidder stage"

## Benefits of Competitive Dialogue – 3

 "It should be recalled that use of the Competitive Dialogue has significantly increased in terms of contract values over the past years. It has shown itself to be of use in cases where Contracting Authorities are unable to define the means of satisfying their needs or of assessing what the market can offer in terms of technical, financial or legal solutions" (Recital 42, Directive 2014/24/EU)

- New rules for Competitive Dialogue in Directive 2014/24/EU
- Competitive Procedure with Negotiation New procedure introduced in Directive 2014/24/EU
- Introduction of Competitive Dialogue in special sectors in Directive 2014/25/EU

Medical equipment, research studies transport services, green energy product testing, ambulances supply/maintenance, building construction, road tunnel construction, data transmission services, telecommunication services, educational software supply, software development services, communications equipment, Wide Area Network supply/services, ambulances supply/maintenance, building construction, waste incineration services, insurance services, integrated testing facilities, nuclear waste treatment, land reclamation scheme, environmental services, power/heating plant construction, electricity meter supply, healthcare services, hydraulic installations, mixed residential/other construction, national transport fare system
