Introduction

Description

This online seminar is designed to help ECA officials understand the monitoring systems and evaluation requirements for the new EU Structural and Cohesion Funds programmes, 2021-2027. We will consider in detail what the new monitoring and evaluation provisions are within the new Regulations and what this means in practice. We examine whether Managing Authorities are collecting the best possible monitoring data. While Programme Authorities are now planning evaluations for the 2021-2027 period, they also continue to conduct evaluations of their 2014-2020 programmes and projects. We ask whether Programme authorities are learning the lessons from ongoing evaluations and if they are clear about how to measure the impact of interventions.
