



Regional Policy 2014-2020 EU Payment rate





European Public Prosecutor's Office (EPPO)

- EPPO is in charge of conducting criminal investigations and prosecutions for crimes against the EU budget
- Only six weeks after EPPO started its operations, it has already processed more than a thousand reports of fraud affecting the financial interests of the EU.

Following your phone call with Ms Salmon, I confirm the cancellation of the second session of the training on identifying and preventing fraud and corruption which was planned on 11th and 12th of March 2020, as a preventive measure with regard to the coronavirus COVID-19 crisis.

I also confirm that this shall be considered as falling into the provisions of Article II.14 of the FWC regarding "Torce Majeure" especially Articles II.14.2 and II.14.3 which provides the following:

"II.14.2 A party is not liable for any delay or failure to perform its obligations under the FWC if that delay or failure is a result of force majeure. If the contractor is unable to fulfil its contractual obligations owing to force majeure, it has the right to remuneration only for the services actually provided."

"II.14.3 The parties must take all necessary measures to limit any damage due to force majeure."

Therefore, the costs already incurred for the second session of the training of identifying and preventing fraud which cannot be cancelled or reimbursed through another source will be paid.

Dear Mr. Lopriore,

Since the outbreak of COVID-19, the organisation of training seminars for Member States experts by EIPA in collaboration with DG REGIO under the framework contract 2018CE16BAT060 has been greatly impacted, i.e. the training sessions planned between March 2020 and June 2020 had to be cancelled or postponed.

The status of the pandemic does not allow us to assume a return to normal in the following months. Under the current circumstances and being concerned about the safety of participants, the Commission prefers to adopt a prudential approach and adapt the teaching and interaction methods by shifting to the online mode.

Recent exchanges between EIPA and unit REGIO E1 have resulted in an adapted training programme for the seminars on *Identifying and preventing fraud and corruption in ESIF 2014-2020* (CCI 2020CE16BAT055) and a proposal to extend the remote training methodology to the trainings on *State Aid* and *Strategic Public Procurement*. I consider the organisation of the training in the form of an interactive webinar to be an appropriate solution and I hereby agree to have the same arrangement for the training sessions under CCI 2020CE16BAT006 and CCI 2020CE16BAT029 planned for the month of September 2020.

I expect the new remote delivery mode applicable to CCI 2020CE16BAT006 and CCI 2020CE16BAT029 to be in line with your technical proposal for CCI 2020CE16BAT055. The situation will be reassessed ahead of the training sessions scheduled for November 2020 and, if deemed necessary, the same approach shall be applied. Colleagues in unit REGIO E1 will be in contact with your on this matter.

Transfers CPR Amendments:

- Art 2.1 CPR: Transfer up to 8% of the allocation as of 1.2.2020 of a PA and no more than 4% of OP budget to another PA" without EC decision

CRII + Reg 2020/558: Radical flexibility

ERDF Scope of support – alignment with TFSA:

- Art 1: Support from OP may be allocated to **undertakings in difficulty**, provided the support complies with TFSA. The definition of undertaking in difficulty can be found in: *Guidelines on State aid for R&R non-financial undertakings in difficulty*
- CPR exceptional increase co-financing rates:
 - Art 2.1: for account year 1.7.2020 30.6.2021, a co-financing rate of 100% may be applied for one or more PA. Requests for modification of the co-financing rate shall be accompanied by the revised OP can only apply if the corresponding OP amendment is approved by EC.

CPR Transfer between funds and regions:

CPR Partnership Agreement (PA):

 Art 2.6: "PA shall not be amended and the OP amendments shall not entail the amendment of PA". The consistency between OP & PA shall not be verified

CPR Examination and acceptance of accounts:

- Art 2.12: For the accounting year 1 July 2019 – 30 June 2020, audit authorities may use a **non-statistical sampling method**

CPR de-commitment and force majeure:

 Art 2.8: For operations below EUR 1.000.000 TEC, information on the amounts for which it has not been possible to make a payment application shall be provided at an aggregate level by priority





3 conditions fulfilled & properly demonstrated on a case-bycase basis:

- are abnormal and unforeseeable
- are beyond the control of the one claiming 'force majeure',
- could not have been avoided despite the exercise of all due care

- From 1.2.2020, projects have incurred cancellation and other costs related to event bookings that cannot go ahead due to COVID-restrictions
- the expenditure will NOT be considered eligible if insurance contract in place = project can claim cost
- if a credit note has been issued, costs are not eligible the project should have exhausted all possibilities to claim the expenditure incurred by other means e.g. travel insurance
- if the project can obtain a partial repayment, only the remaining costs are eligible

Merging ESF+ Regulation CPR covers only shared management of ESF+...
