### Partnership Council

UK minister co-chair | Meets at least once a year  
 Makes binding decisions (including amendments), and non-binding recommendations | Can discuss any dispute or issue  
 Delegate functions to the Trade Partnership Committee or specialised committees | Create or dissolve committees

#### Trade Partnership Committee

Duties given to it by the PC, including making decisions  
 Can be co-chaired by a UK minister or official  
 Supervise the committees below | Supervise working groups  
 Explore ways of preventing or solving trade difficulties

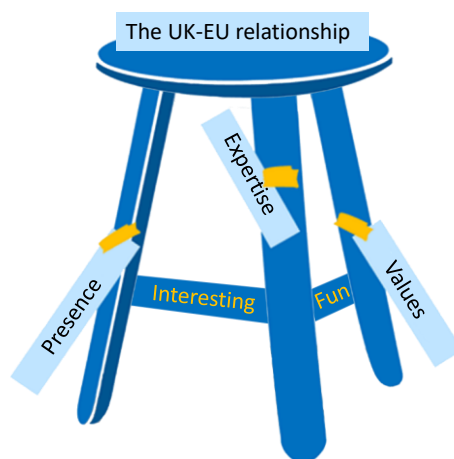

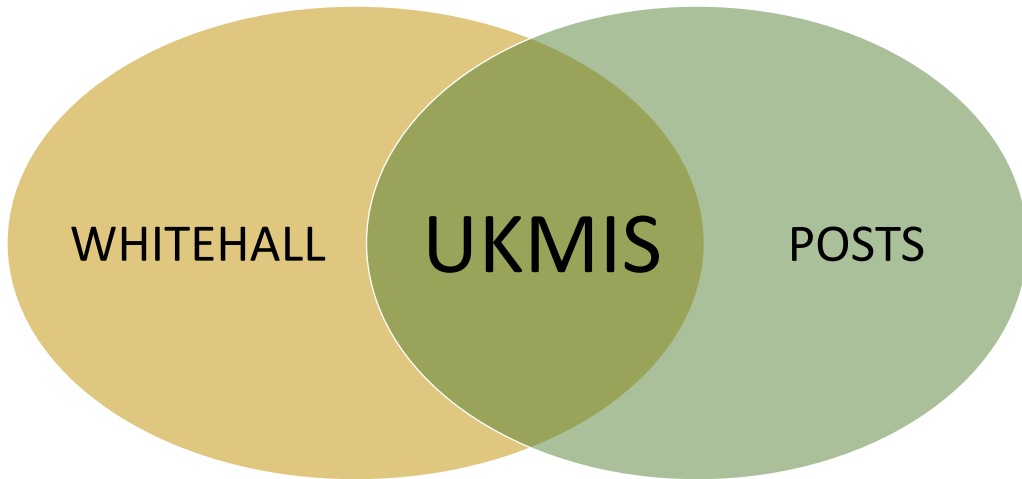
